



## **WAIVER AND RELEASE OF LIABILITY**

In the event that I should require medical care or treatment, I agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

In the event that any damage to equipment or facilities occurs as a result of my or my family's willful actions, neglect or recklessness, I acknowledge and agree to be held liable for any and all costs associated with any such damage.

I consent to photo images being taken by the BVSPCA, its staff, volunteers or representatives during this Activity, and to such images being used in any or all BVSPCA publications, social media and websites.

Any legal or equitable claim that may arise from participation in the Activity shall be



resolved under Pennsylvania or Delaware law.
